EERA, the European Electronics Recyclers Association operates www.eera-recyclers.com and working with a database of EERA members (companies and persons) in E - captain (<https://www.e-captain.nl/inloggen>) and an EERA members mailing list, which is managed by EERA secretariat. This page informs you of our policies regarding the collection, use and disclosure of Personal Information we receive from users of the site.

We use your Personal Information only for providing and improving the EERA website or EERA objectives. By using the EERA website, you agree to the collection and use of information in accordance with this policy and to inform our members with latest information in the field of the WEEE business.

Information Collection And Use

While using our Site, we may ask you to provide us with certain personally identifiable information that can be used to contact or identify you. Personally identifiable information may include, but is not limited to your name ("Personal Information").

Log Data

Like many site operators, we collect information that your browser sends whenever you visit our Site ("Log Data").

This Log Data may include information such as your computer's Internet Protocol ("IP") address, browser type, browser version, the pages of our Site that you visit, the time and date of your visit, the time spent on those pages and other statistics.

In addition, we may use third party services such as Google Analytics that collect, monitor and analyse this for improvement of the site and EERA objectives.

Communications

We may use your Personal Information to contact you with newsletters, marketing or promotional materials, information related to events, congresses and other information that is of importance to share, all related to the EERA objectives.

Cookies

Cookies are files with small amount of data, which may include an anonymous unique identifier. Cookies are sent to your browser from a web site and stored on your computer's hard drive.

Like many sites, we use "cookies" to collect information. You can instruct your browser to refuse all cookies or to indicate when a cookie is being sent. However, if you do not accept cookies, you may not be able to use some portions of our Site.

Members information

EERA manages membership databases (in Dispi / E - captain (<https://www.e-captain.nl/inloggen>) and at EERA secretariat) with information about its members: recyclers and persons. This database collects information like contact information, profession, special interests and invoices all related to the objectives of EERA and with the purpose to service the EERA members and to improve the EERA association.

Security

While we strive to use commercially acceptable means to protect your Personal Information, we cannot guarantee its absolute security.
